

Please initial the following:

___ I understand that although all dogs are fully supervised, incidents or injuries may occur from playing with other dogs, which includes but is not limited to bites, scrapes, scratches, and sprains. I release KPC/CAB, its staff, owners, and any representatives from any and all liability which I or my dog(s) may suffer including but not limited to injury, sickness, damage, or death resulting from participation in daycare and boarding.

___ I recognize the inherent risks associated with being in a social environment while my dog is in her heat cycle/season. I assume full responsibility for any action(s) that may arise from my female dog being in heat cycle/season before, during, and after leaving KPC/CAB. I will not hold KPC/CAB Liable. KPC/CAB do not accept any responsibility should your dog become pregnant.

___ If my dog is in heat, I agree to pay an extra \$10 per day for cleaning, sanitation, and separation. An additional fee on top of the \$10.00 will be added for all supplies (pads, diapers, wipes, etc.) that need to be purchased.

___ Payment for all services are due before or upon drop-off of your dog(s).

___ I understand that there are no refunds for services purchased.

___ I release, indemnify, and agree to hold Kara's Pet Care, LLC, and Canine Academy of Berwick, LLC, harmless from any and all manner of damages, claims, loss, liabilities, costs or expenses, causes of actions or suits, whatsoever in law or equity (including, without limitation, attorney's fees and related costs) arising out of or related to the services provided by KPC/CAB, except which may arise from the sole gross negligence or intentional and willful misconduct of KPC/CAB, including, without limitation, (i) any inaccuracy in any statement made by myself or information provided by me to KPC/CAB, (ii) your dog, including but not limited to destruction of property, dog bites, injury, and transmission of disease, and (iii) any action by myself which is in breach of the terms and conditions of this agreement.

___ First and foremost, the safety and well-being of your pet(s) is of the highest importance. Insuring that your pet remains safe and well cared for is our first responsibility and as such we take it very seriously. We do our best to have our pet parents screen for pre-existing health conditions but some factors may be beyond our control. In an emergency, KPC/CAB will attempt to contact the Owner, the Pet's personal veterinarian as well as the emergency contact provided by the Owner. However, such an emergency might not provide the time to do so prior to the administration of care. The Owner authorizes KPC/CAB to obtain medical attention for the Pet from any qualified veterinarian, and to transport the Pet to and from that veterinarian when KPC/CAB deems such medical care is important to the Pet's health. The Owner grants KPC/CAB or its employees or agents full power of decision making involving the medical treatment of the Pet, and agrees to pay all costs. This applies to any claims for injuries or damages related to such medical care or transport.

___ I understand that this pet will be relinquished to the care of Canine Academy of Berwick, LLC if not picked up within 10 days of program completion.
